

# Accessibility statement for Meeting Mojo

Website accessibility statement inline with Public Sector Body (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018

This accessibility statement applies to frontend (public access) web sites generated via the Meeting Mojo application.

The websites are supported by Meeting Mojo Ltd and are created either by our customers or by our own operatives. The websites are used by people who attend events (real or virtual), and by event managers, and we want as many in these groups as possible to be able to use them.

- change colours, contrast levels and fonts
